Following a strategic review of our business, MII has decided to close several PCEIA & CEILLI examination centres for the Paper and Pencil Examinations (PPE) in 2017.

This closure is due to the increased in demand and preference of candidates to sit for the computer-based examination (CBE) which enables them to obtain their results immediately.

In line with this development, with effect from January 2017, MII will close the PPE centres, i.e Alor Setar, Penang, Ipoh, Kuala Lumpur, Seremban, Melaka, Batu Pahat, Johor Bahru, Kuantan, Kota Bharu, Kuching, Miri and Kota Kinabalu.

As an alternative, candidates are able to register at 11 CBE centres, i.e. Penang, Sg. Petani, Ipoh, Kuala Lumpur, Melaka, Johor Bahru, Kuantan, Kota Bahru, Kuching, Miri and Kota Kinabalu. However, the Kuala Terengganu, Sibu, Bintulu, Labuan, Lahad Datu, Tawau and Sandakan examination centres will still remain as PPE centres. Please refer to the 2017 PPE schedule attached below. We seek your cooperation and support to inform your member companies and agency members accordingly.

### 1. Minimum requirement

#### PCEIA:

- SPM/MCE with 5 (five) passes or other qualifications deemed equivalent or higher and which must be academic- based.
- A scanned copy of certified certificate(s) must be attached.

#### CEILLI

- Candidates who intend to sell investment-linked products must first be contracted as life agents.

### 2. Registration

- Online registration must be done through [www.mii4u.org](http://www.mii4u.org).
- Withdrawal, cancellation and postponement of the examination are not permissible and no refund will be given.
- Candidates who wish to sit for Part B or Part C only must successfully complete Parts AB (General Insurance route) or Parts AC (Life Insurance route) before registering for the examination.

### 3. Examination

- Notification of e-permit will be emailed to candidates upon approval of the registration.
- Candidates must produce the hardcopy of their e-permit and their original Identity card (NRIC) before entering the examination hall / room.
- The Institute reserves the right to not allow candidates from taking the examination if they are late by more than 30 minutes from the start of the examination.
